1. Welcome

5. Old Business

a. ASCA Meeting/Workshop

c. Trustee Report

- The MacKinnon Report

This Report was developed by an Independent Panel of Experts and recommended a path towards a balanced budget. 2 recommendations pertained to education and High Prairie School Division.

Recommendation 5 – Decrease the percentage of government funding that goes to K-12 administration and governance (currently 25 per cent) to a level comparable to British Columbia (17 per cent).

Recommended a decreased amount of government funding going to admin and governance. Alberta had higher percentages than other provinces such as BC. HPSD had a concern with this recommendation because of different interpretations of what constitutes admin and governance in different provinces. For example busing was part of those admin percentages and different rules for when students are eligible to take a bus to school are set out in each province.

It was recommended that High Prairie School Division do a thorough review of the McKinnon Report.

Recommendation 6 - Completely review and revise the current K-12 education funding formula to ensure enrolment growth is addressed and provide incentives for sharing services and achieving better education outcomes for students.

High Prairie School Division understands this to mean that they should try to find efficiencies wherever they can. One way possible is to try to share bussing with other school Divisions. However Rural Areas are different than urban.

- Vaping

High Prairie School Division feels that there should be an admin procedure with respect to Vaping and is gathering feedback and information. Karen obtained feedback from the School Council to bring back to HPSD.

Smoking has an admin procedure (#470) saying no minor student shall smoke, there is no smoking in buildings or on the school grounds, and a minimum of 5 metres from doorways. These also apply to staff and mature students.

Rules are slightly different for schools depending on whether elementary or secondary school.

Vaping is hard to enforce because it is hard to catch.

- Minister of Education

The Minister of Education has promised to visit each School Board in the Province. High Prairie School Division is preparing some Messages for her including:

- Recruiting specialized teachers
- With the New Curriculum coming they would like to see as much notice as possible with information coming in a timely manner.
- They would like information on Assessments such as PAT's.
- They would like to advocate for long term predictable funding.
- They would like to see rural seats allocated for Post Secondary Education
- With respect to rural areas there are sometimes missed opportunities due to timing of courses
- MELT – Mandatory Entry Level Training – asking for bus drivers to be exempt
- Recruiting and Retaining bus drivers
